# What has happened since our last meeting?

- Andrzej Jola, Krzysiek, Renata and Zbyszek met on Tuesday evening and worked on improving the script for the meeting with the General Consul, Dr. Paweł Zyzak and Honorary Consul, Ryszard Walawender which will take place in January.
- One of Jola's sons started reading "Kaz...". So far no one has done it.
- Gienek received links to the meeting in Warsaw on retirement organized by the Coalition of Polish Americans (CPA) in October

# We talked about:

- <u>Visiting US National Parks</u>. Edmund was asked by Zbyszek to tell us more about his trip and to send photos from the trip on a platform where we could view them.
- <u>State of Texas</u>. We learned a lot from Jim about the only state that once was an independent country that joined the US. Texas is the 8th largest economy in the world with the population of just 30 million. It has an interesting part-time legislature that meets every two years to vote on the budget. Only the Governor works full-time, members of the house and senate have to work to support themselves which makes them more sensitive to the common people (they get only \$600 per month from the state). Only 3 other states have a similar system: Montana, Nevada and North Dakota.
- How to reach young people to convince them to read Dr. Bogdan Kotnis's book.
- <u>Meeting in Warsaw on the calculation of pension.</u> Gienek analyzed the meeting and shared his opinion with us. it seems that there was no planning and agreement with Ordo luris as to what expectations of Polonia: A. there was not a single question as to why CPA did not receive a reply to its letter sent in February. B. instead of asking why the Polish law which allows pensioners to choose their preferred method of calculation, is not respected. Instead, Mr. Jerzy Kwaśniewski asked to put pressure on American legislators to repeal the WEP. It is funny because the purpose of this meeting should be to put pressure on Polish officials and lawyers to comply with Polish law.
- <u>A key goal of the meeting with Consuls and the proposed list of participants</u>. The goal and participants were generally accepted. Krzysiek proposed to exclude members of one of organizations Only Zbyszek agreed with his reasoning. No decision has been made on how to resolve this impasse.

# Following decisions were made:

- Jola proposed and all agreed to write another letter to minister Anna Schmidt retirement calculations in Poland. This time, not only the CPA should sign but also several organizations.
- Gienek asked Andrzej to remind the CPA President about the promised meeting on pensions received by immigrants.
- Gienek suggested not to give up, after our efforts failed, but to think about a plan to deal with WEP.

### What has happened since last our meeting before Thanksgiving week?

- On Monday (11/21/2022) we met with Rep. John Larson at noon. Instead of half an hour, we talked for an hour and a half. WEP and H.Res.664 were main topics. The meeting was arranged by Dr. Krystyna Zamorska.
- Nov. 4 was Thanksgiving, so we did not have our regular Thursday meeting. I hope that all PACT'19 activists and supporters spent this time in a special way.
- Gienek met the Consul General of Polish Republic and talked about retirement calculations in Poland and our efforts in this matter, also about support re H.Res.664.

#### We talked about:

- The Katyń Monument: >the trial will begin in April, said Wojtek J., President of PASI
  > what was achieved through negotiations with Jersey City councilors, reported by Bogna Huan and Wojtek Mazur, President and Vice President of Committee Conservation Of Katyn Monument And Historic Objects. After their presentation there was a Q/A session. Their efforts seem to be paying off. Everyone was grateful for their achievements so far and wished them good luck in their further struggle,
- The Jewish Federation of North New Jersey was informed by Krystyna about the problems with the Katyń Monument.
- Meeting with Rep. John Larson.
- WEP. Gienek invented a fairer method of applying WEP and presented it to us.
- Orchard Lake Schools (OLS): > who else we should invite to the Coordination Team and when and at what time we should schedule the 2nd meeting of this group. The request for an audience with the Archbishop prepared by the Coalition of Polish Americans was mentioned. > two CPA special meetings on OLS were discussed. Jola told us that she did not believe that Archbishop Vigneron wanted to close the Seminary.
- Social Security calculations are based on 35 years of work if one has worked less, those yeas are taken into account as 0 which in effect lowers Soc. Sec., Gienek explained to us.

#### Following decisions were made:

- Gienek will send his proposal of a new approach to WEP; whose Soc, Sec, recipients should be omitted from WEP.
- Krystyna will contact George Wang, Legislative Assistant of Rep. Larson, regarding H.Res.664 and will present the proposal prepared by Gienek re WEP.

#### a guide prepared for a meeting with Rep. John Larson

Rep's or Krystyna introduction.

[**Dr. KZ**] We appreciate this opportunity to meet with you personally and to bring to your attention the interests of Polish Americans. We work and hold offices within several organizations, such as the Polish American Congress, Coalition of Polish Americans, Polish American Council of Texas and Polish American Strategic Initiative, living in states such as CT, IL, TX, NY, NJ, MO, CA and DC. We have two issues which we would like to bring up today: a. Profoundly unjust impact of WEP on Polish (and other immigrant) retirees;

b. Co-sponsoring of H.Res.664 in the context of the current geopolitical developments.

**[AB]** We often hear heart-breaking stories from people whose retirement benefits are heavily affected by the Windfall Elimination Provision (WEP). For example, if the retirement benefit (AIME) is \$1,024, then the WEP deduction is \$512 (50%), which is the case with most Polish immigrants. As you are probably aware, WEP deduction places them below the poverty level, and they usually have to rely on other government assistance programs, such as Supplemental Nutrition Assistance Program (SNAP). Presentation of an example. Will the Congressional Majority Leadership allow to vote in the House on H.R.82 and end of this injustice in this year?

[after Rep's reply, continuation by AB] We are appalled to see that HR.82 once had 211 Democrats co-sponsoring, and now its Discharge Petition 117-17 has not a single Democrat supporting it. Would you comment on this? Would you sign 117-17? What can be done to obtain bipartisan support on this issue?

[**Richard**] As Polish Americans, we are interested in issues affecting the United States as well as Poland. The lack of knowledge and distortions created in the cold war era continue to negatively affect the public perception of Poland even today. As you are aware, H.Res.664 "Commemorating the anniversary of the invasion of Poland and recognizing the importance of the United States alliance with the Republic of Poland" has been introduced almost two years ago. Present geopolitical situation underscores its importance, yet not a single member of the Poland Caucus has co-sponsored it. As a member of the Poland Caucus, would you enlist as a co-sponsor and encourage other members of the Caucus to do the same?

#### Ending the meeting:

[**Dr. KZ**] we were very pleased to be able to present our concerns. Congratulation on your reelection. We look forward to establishing a two-way communication channel with your office.

- To invite representatives of Polonia, willing to meet Congressman Larson, on Monday, November 14 at 8 PM. Also, we must update the script we prepared a few weeks ago.
- To inform the General Consul of RP, Paweł Zyzak about the lack of response to the letter re the calculation of the retirement pension entitling to the application of WEP. The letter was sent to Minister Anna Schmidt in February. Gienek could also refer to the opinion of Minister Dziedziczak that Polonia is in a conflict which indicates that he does not know about the PACT initiative.
- To continue contacting the Poland Caucus and persuading congressmen to co-sponsor H.Res.664.

# What has happened since last week's meeting on Thursday?

- Andrzej volunteered to be an observer during the upcoming US elections.
- Edmund just returned to Poland after traveling in the US for several weeks. To share his story, he needs some time to recover from this grueling journey.
- Andrzej described the progress of work around the Katyn Monument: the apron was removed by a pneumatic hummer attached to a heavy machine, The monument was not protected in any way.
- Zbyszek participated in 3 meetings during one day (Oct.25): he talked with Dr. Mark Pienkos, about the next PAC election, with Andrzej and Krzysiek worked via Skype on a letter to OLS Regents explaining why the CPA decided not to organize its annual meeting in OLS, the 3rd meeting was organized by Krzysztof Gajda from Texas via Zoom re a petition to Archbishop of Detroit with a request to maintain the status for the Seminary as open (not to eliminate it from OLS) and the idea of organizing a meeting of Polonia activists was proposed and discussed. The last meeting was attended, among others, by Waldemar Biniecki, the publisher of Kuryer Polski. The meeting ended after midnight

### We talked about:

- <u>What are the chances with H.R.82 and H.Res.664</u> to be accepted and what are the further plans. The end of 117<sup>th</sup> session of Congress\_ends on December 16, Gienek reminded.
- <u>Searching for anti-Semitic incidents.</u> Krysia: the main reason seems to be the popularity of the slogan "Black Lives Matter" which dominates the public narrative
- <u>An action in PAC to obtain donations of \$100.</u> Ryszard found that 32 people had donated.
- <u>"History stop"</u>. Krysia mentioned about the meeting of PAC and the Institute of National Remembrance leaders that took place in Chicago.
- <u>Current events at the Polish American Museum</u>: an exhibition of paintings and a lecture about the first Polish student at the West Point Academy, were presented by Ryszard.
- <u>"Task Force to combat anti-Semitism". Ryszard told us about the formation of a new</u> <u>group by Long Island County Leaders.</u> The task force will consist of six legislators three Republicans and three Democrats — as well as the county executive or his designee. The legislators will then pick five community leaders to also be on the task force, based on their expertise and background in opposing antisemitism.

# Following decisions were made:

- Ryszard will contact Mr. Mikołaj Rej and ask him if he would be interested in running for VP for Polish Affairs in next year elections in the PAC.
- Andrzej will continue to try to convince Mr. Antoni Wnękowicz to participate in the PAC elections. So far, no one we know is interested in running.
- Krysia will investigate who runs the National Museum of WWII in Texas.
- Zbyszek will call his congressman's office to ask if representatives have to wait for the days when the congress will be open to get their names on the documents and will ask why we have problems finding sponsors for H.Res.664, also will ask Rep. Suozzi to become a co-sponsor of H.Res. 1367 which will force a vote on H.R.82 (this law will repeal WEP & GPO).

# What has happened since last week's meeting on Thursday?

- Krystyna attended the annual local panel of Social Studies (admission: \$70). Participation was reserved for members of the Connecticut Social Studies Council (\$10-20 dues). 4-5 lectures, 50 min each, were held in several rooms
- News from the just completed, annual PAC ND meeting in Chicago: Mr. Spula is nearing the end of his term (as of the revised By-Laws), so he will not be able to run in next year's elections and Mrs. Bozena Kaminski announced that she would not run for re-election. Zbyszek is not liked by PAC leaders because "he has a bad approach to getting things done". H.Res.664 was criticized for containing the word "genocide ".
- Reminder: On Monday September 19, 2022, H.Res.1367 was introduced for the purpose of filing a Discharge Petition. The resolution creates a special rule to trigger a vote on H.R. 82. 218 signatures are needed but so far only Republicans (22 of them) have signed it. 2 Democrats who signed up withdrew, possibly at the request of Ms. Pelosi
- Krysia did not get any info from the Rep. Larson's office about the promised meeting regarding repealing of WEP & GPO.

# We talked about:

- The Report of last week's meeting was read and some items expanded/explained.
- <u>Director, Robert Wójcik</u> is responsible for the internal guide for Polish officials which causes WEP to be applied for many years which significantly reduces retirement pensions. Gienek once again explained all aspects of the matter and regretted that the letter had not been read at the Conference in Warsaw. In the letter sent at the end of February everything was explained very well (Jacek had its copy with him).
- <u>The exploitation of Jan Karski</u> was noticed by Krysia. The play about Karski had the same supporters as the "Festiwal Mazurka Gen. Wybickiego".
- <u>Possible candidates</u> for next year's KPA election: Witold Łukaszewski, Mark Pienkos and Antoni Wnękowicz were mentioned.
- <u>The CPA meeting at Orchard Lake Schools</u> was canceled. It will be conducted via the internet. Opinions were expressed.
- Details of the arrest of Mr. Janusz Roland and its legality.
- <u>The elections for the position of OLS chairman</u> were announced. They will take place on October 24.

#### Following decisions were made:

- Andrzej will talk to Mr. Wnękowicz about his possible candidacy and Zbyszek will talk to Dr. Pienkos about his suggestions.
- Krysia suggested that our organizations help selected Polish students through travel awards to participate in the annual international 3-day meeting of the American Historical Association. This will give PAC and CPA exposure and students new experience.
- The CPA position should be announced publicly following the arrest of Mr. Roland.
- Krysia: Social Studies Councils are in every state and we should encourage CPA and PAC representatives to join them.
- Krysia once again reminded us about spreading the news in Polonia about the job opening for the Director of the Museum of WWII in New Orleans.

# What has happened since last week's meeting on Thursday?

- Gienek sent us regulations on non-for-profit organizations: they are not "owned" by the people who start it, nor their successors. These individuals operate in a position of trust and accountability for the public at large. A nonprofit cannot be sold. Without an ownership mechanism isn't possible. If operations end, the board of directors must distribute all of the assets to another 501(c)(3) after all debts have been settled.
- Jola sent us her article which appeared in the recent "Gwiazda Polarna. Janusz Roland was arrested at the event of unveiling of Gen. Haller's Monument., when the Polish Anthem was sung.
- Jacek and Zbyszek reported on the meeting with Minister Jan Dziedziczak and Director Badowski in the auditorium of the Media Center in Toruń. The event was a part of the "Festival Mazurka Wybickiego" organized on Sept. 28-30 by President of Republika Polonia, Dr. Maria Szonert Binienda .
- Krysia: there was an election debate between Democrat John Larson and Republican Dr. Larry Lazor, on PBS. WEP was mentioned.
- Krysia did not hear from Rep. Larson's office about the expected meeting.
- Gienek received a standard answer, unrelated to H.Res.664, from Rep. Warner.

# We talked about:

- Mass closures of Catholic churches in America. Gienek: out of 170 parishes, only 80 will remain in Roman Catholic Metropolitan Archdiocese of Saint Louis. Krzysiek: only parishioners can save the church, not the hierarchy.
- Future involvement of our group: lessons for Polonia children.
- Details of the arrest of Mr. Janusz Roland.
- Meeting in Poland with officials on the proper method of calculating retirement.

# Following decisions were made:

- Krystyna will attend a local Social Study panel to find out what is going on.
- Zbyszek: after finishing our involvement in lobbing, we should start working on the lessons. Krzysiek suggested "How to protect myself against anti-Polonism", Zbyszek: "Why should I be proud of my Polish heritage".
- All agreed that the suggestion to invite all OLS Regents should be communicated to the CPA board. As an organization not directly involved, the CPA has the potential to make a positive impact.
- Krzysiek: the video recording of the scandalous arrest of Mr. Janusz Roland should serve as a great propaganda tool showing how Polonia is being treated. Zbyszek suggested asking Edmund to post it on Facebook with a relevant comment.
- Andrzej, Krzysiek and Zbyszek should meet and prepare a script on how to appeal to members of Caucus on Poland re H.Res.664 and Democrats re H.R.82.

### What has happened since last week's meeting on Thursday?

- Tomek called Rep. Marty Kaptur and was told that they knew about H.Res.664.
- Jola was informed, when she called her Rep's office on H.Res.664, that Rep. was very busy.
- Jacek participated in a Conference organized by the Coalition of Polish Americans (CPA) in Warsaw. The talks with representatives of the Ministry of Anna Schmidt concerned the methods of calculating the retirement pension in Poland, one of which makes WEP applicable to Polish immigrants. - Gienek was handing out leaflets to parishioners after a mass encouraging them to contact Rep. Nancy Pelosi about H.R.82 (Soc. Sec. Fairness Act of 2021).

#### We talked about:

- North Stream attacks were mentioned.
- H.Res.664 the results of an attempt to engage Frank Spula, President of the Polish American Congress to make an Appeal to Polonia were discussed. Only a small note appeared, additionally posted not on the weekend but on Thursday.

- We must continue searching for members of the Polish Caucus. Our last chance is to write letters to members of the Polish Caucus re H.Res.664 signed by PAC divisions.

# What has happened since last week's meeting on Thursday?

- The meeting of the National Directors of the Polish American Congress (PAC) was announced. It will be held in the auditorium of the Polish National Alliance (PNA) on Oct.19-20<sup>th</sup> (Wednesday, Thursday). The \$185 Registration fee includes lunch and dinner. Hotel Hayat was reserved for participants at a discounted rate.
- The anniversary of the invasion of Poland by the Soviet Union was organized by Wojciech Mazur, VP of Business Affairs of the Committee for the Conservation of the Katyn Monument & Historic Objects at the Katyń Monument in Jersey City on Sept.18 (Sunday). Andrzej was there and here is his short report: children with teachers from 4 Saturday schools were present, Sławek Plata spoke among others, over 100 people attended, a rep of the Polish Consulate, PAC-DSNY and City Council were present. The event was recorded and the ink can be found on Facebook.
- H.R.82 has 302 (210 D, 92 R) cosponsors, but was nevertheless removed from the Consensus Calendar and only the Speaker of the House can save this bill, Gienek reminded us. Of the 221 Democrats in the House, 210 are co-sponsors of H.R.82. After the debate, the bill came out of the Ways & Means Committee without a recommendation. Overall, 70% of the representatives support the bill, yet it has minimal chance of being voted because Rep. Larson refuses to support it.

### We talked about:

- What students learn about history. Krystyna: there are over 300 Holocaust centers in the US. Russia does not exist in the context of WWII. In the field of history, great emphasis is now placed on "diversity, equity, inclusion" which gives us the opportunity to present our history.
- H.Res.664 why there is no progress and what we should try now. Krzysiek accused Zbyszek of not spending enough time developing a strategy that would bring results.
- The Katyń Monument what will happen to it and why the trial has not brought the expected results yet.

# Following decisions were made:

- According to Krystyna, Andrzej could present the Katyń Lesson in a discussion panel to which she enrolled him and the Institute of National Remembrance. This event will take place on October 14<sup>th</sup>.
- We have decided that the best time to meet with Rep. Larson would be when we have our weekly meeting; on Thursday at 3 PM.
- We agreed with Krzysiek's proposal to concentrate our efforts on convincing the Polish Caucus to get involved in the action re H.Res.664. It will be a discredit and a shame for this group if it does not support us.
- Zbyszek will ask Richard to find out if the planned meeting between Rep. Marcy Kaptur and Mr. Kuzma and John Czop was held and what was its result.

Regents may transfer but not sell OLS real estate.

# We agreed to:

- Andrzej, Krzysiek and Zbyszek will improve the script of the meeting with Rep. Larson.
- We should all strive to find candidates for Orchard Lake Schools Regents. Zbyszek will turn to Dr. Stanisław Śliwowski and Fr. Rożek. According to Władek following attributes are required: corporate experience, active membership in a large organization, appropriate education, good financial standing and willingness to donate.
- Zbyszek will make changes in the previous report, mainly to switch Fr. Król with Fr. Witek, as suggested by Jola.

# What has happened since the last meeting on Thursday evening a week ago?

- Zbyszek talked with the rep. of Polish Lobby about Orchard Lake Schools (OLS).
- On Monday and Tuesday some of us met to discuss what we should say to Rep. Larson.

#### We talked about:

- OLS for 3 hours. The discussion deepened our knowledge of this institution and will help us take appropriate actions. We learned that 50% of all 1,200 HS students are Arab Catholics. The Archbishop did not oversee the Seminary as he should, as head of Seminary's Trustees. There was no Rector for last 5 years until Fr. Witek. The accusations led to his removal. This was one of the reasons for closing the Seminary in June 2021. False info about the suspension of recruitment in Poland, was another that convinced the Regents and Trustees to close the seminar. In Nov. 2021, this decision was revoked after corrections sent by Polish bishops. The cost of educating a priest: \$50 k a year for 5 years of study. Payment in advance by the diocese would help. Min. 15 clerics would be required. Regents can sell/give OLS to another 501c3 corporation. Biggest threat: Regents will gradually eliminate Polish organizations from OLS. Work on new amendments to By-Laws began. The lack of transparency is a fact. The historic military barracks were demolished and a new building will be erected.
- <u>Katyń Monument</u>: what can we do next when the fence was erected in preparation for implementing the landscaping plans. Has the court accepted our complaint?

#### We agreed to:

- organize a meeting of Polonia and the Archbishop of Detroit, Allen Vigneron, as suggested by Andrzej. Goal: to convince him not to eliminate but only temporary close the Seminary. Władek will try to gather a representative group.
- contact the Attorney General for info about OLS.
- talk to Regents who are not Poles, as suggested by Andrzej.
- contact Fr. Wróbel to open a branch of KUL in OLS, as suggested Gienek.
- continue working on the script for the meeting with Rep. Larson. Zbyszek will modify Andrzej's draft based on the message Krystyna received from Nancy Perry.

- Indexing it is not easy to implement in PDF. The easiest way is to transfer to WORD.
- \$ 5.5 million was approved for landscaping of the area around the Katyń Monument.
- 2 hours we talked about OLS and its documents that Gienek carefully analyzed

- We will have extra meetings to prepare for a conversation with Rep. Larson.
- We agreed on a preliminary list of participants and Zbyszek will notify them. Additional suggestions are welcome.
- Jacek offered to call Cori Bush, MO 1. Gienek will remind him.

#### Letter FROM NANCY PERRY below:

Nice to talk to you! 1) The Congressman fully supports repeal of WEP and GPO. 2) The repeal of WEP and GPO will likely cost \$85 billion or more for the next 10 years (and so much more over 75 years which is how the Social Security Administration measures impact on Social Security Trust Funds.) Congressman Larson cannot cosponsor HR 82 when it does not make up that revenue which will hurt the Trust Funds and hence, all beneficiaries. 3) If there is not enough in the Trust Funds to pay benefits, the benefits will have to be cut.

Attached is information about the Congressman's bill which is going to be voted on in Committee in the next week or two and then will go to the House floor for a vote (note we will be amending the bill to change the effective dates to January 2023 because the Social Security Administration cannot implement new benefit changes in the current year.) 4) His bill not only repeals WEP and GPO, but expands and improves Social Security benefits for all beneficiaries, ensuring that beneficiaries will not retire into poverty (as millions do now.) He pays for these benefits by applying the Federal Insurance Contribution to those earning over \$400,000. The wealthy should pay the same rate of FICA as someone earning \$50,000. 5 ) It is a matter of fairness.

Dear Members of the Jersey City Council,

The POLISH AMERICAN CONGRESS (PAC), established in 1944, represents the interests of over ten million Polish Americans. The PAC has divisions in nineteen states, including three in New Jersey. The mission of the PAC is to advocate and campaign for legislation that strengthens the relationship between Poland and the United States, and protects the interests of Polish Americans. The Katyn Monument in Jersey City is a precious reminder for all Americans of the price that must be paid for freedom.

The PAC maintains close relationships with members of Congress, as well as legislators in State and Municipal governments. The United States and Poland have been close partners in freedom since the American and Polish revolutions of the late eighteenth century. Our shared commitment to the defense of freedom drives the PAC's policies.

The PAC strongly supports the April 26, 2022 decision of the Jersey City Planning Board NOT TO RECOMMEND plans for improvements to the Exchange Place Pedestrian Plaza proposed by the Exchange Place Alliance Special Improvement District (EPASID). I respectfully request that the members of the Jersey City Council agree with that decision of the Jersey City Planning Board, despite the fact that it was later reversed under pressure from the EPASID. Polish Americans DO NOT support the proposals of the EPASID.

Although Ms. Elizabeth Cain, Executive Director of the EPASID, recently claimed that Polish Americans support the improvement plans, her claim is based on incorrect information. Ms. Cain based her claim on her discussions with the Committee for the Conservation of the Katyń Monument & Historic Objects, a small recently organized group without mass support. These talks were later reflected in an article approved by her and published in the *Post Eagle* weekly newspaper, written by Mr. Wojciech Stan Mazur, Vice President for Business Affairs of that organization. Polish Americans oppose and protest construction at the Katyn Monument as proposed by EPASID.

Ms. Jeanne Daly, a spirited resident of Jersey City, was the recipient of the Polish American Congress New Jersey Division's OUTSTANDING CITIZEN AWARD FOR 2018. She is an asset in maintaining the Katyń Monument in Exchange Place, and has spent years working with Mr. John Czop, Director of Policy Planning at the PAC Washington Office, who lives in New Jersey, and with Mr. Andrzej Burghardt, President of the PAC New Jersey Division.

# What has happened since the last meeting:

- Andrzej: on June 24, 2-count complaint was submitted to the court in New Jersey: 1. EPA-SID did not consult its plans with the public, 2. On May 10, the City Planning Board did not allow comments. Plaintiffs: Jeanne Daly, PASI, PASI-EDU. Wojtek paid Lieberman & Associates \$5 k.
- Ryszard: according to John Czop, President Spula is going to write a letter to the Jersey City Board re the Katyń Monument.
- Ryszard received a copy of Łucja's letter to the Archbishop of Detroit (attached).
- Celina shared a proposal on the role, Polonia could play in cooperation w/ Poland.
- Yesterday (Wednesday) Jeanne Daly and Andrzei were present at the meeting in the Jersey City Municipal Council at the City Hall. Andrzej read his objections to "beautification" and sent them to the municipal clerk.
- At the "Man of the year" gala, organized by Pułaski Association of Business and Professional Men held last Friday, Ryszard was awarded the title of the Man of the Century. He should be a role model for everyone, especially for the younger generation.
- At the Friday gala, Zbyszek talked with Sławek Platta, Esq about the Monument and with Fr. Piotr Rożek, chairman of Polish American Priest Association (PAPA) about Orchard Lake. Sławek argued that a law suit will be a waste of money and the only way to succeed was to alert the media and make a demonstration. Fr. Piotr: priests know about the closing of the Seminary. The lack of clerics should force us to invent something new, to keep OLS Polish.
- Halina & Zbyszek went to Philadelphia for a wedding for the weekend and managed to visit the interesting Tadeusz Kościuszko Museum in the house where he was staving. The photos are under previous report. https://www.nps.gov/articles/getaway-thko.htm

#### What we learned at the meeting:

- Andrzej warned about Alicja Woźniak who appears to be an operative who destroys Polish American org. for example the Clark Polish Cultural Foundation in NJ.
- Gienek presented his discovery that Orchard Lake Schools (OLS) is a child of the parent organization, the Conference of Catholic Bishops. Thanks to them OLS has the status of 501c3 and is obliged to send annual reports to its parent organization. All non-profit organizations have been called private organizations since the 60's.
- Władek: the Regents rule OLS and they can suspend the Seminary but can't remove it.
- Władek: over 100 seminars in the USA have been closed. If we want this place to be Polish, Polonia should support the events organized there, not ignore them and should stop fighting the Regents.
- Edmund: a bill becomes the law without the President's signature 10 days after it is passed by Congress.
- Zbyszek shared what happened at the WEP/GPO Task Force meeting on Monday.
- The new initiative. "Polska Jest Jedna" (PJJ) was born 9 months ago https://fb.watch/dVMoGMF5Q4/
- Krystyna listened to lectures at the Ronin (ownerless samurai) Club in Warsaw about Ukraine and in the 2nd part about Russia: https://www.youtube.com/watch?v=Gxg9HKdvqs4

#### What we agreed that should be done:

- Gienek proposed to write a letter, to the Conference of Catholic Bishops to obtain Bylaws and other OLS documents. The PAC should be asked to send such a request.
- Halina suggested contacting the chairman of the Katyń Committee, Krzysztof Nowak and asking him to organize a demonstration against the EPA-SID plans.
- Edmund argued to concentrate on Rep. Larson to release H.R.82 from his committee.

#### Your Excellency,

I am writing to you to request that you keep open our beloved and historic SS. Cyril and Methodius Seminary at Orchard Lake.

The decision to close the Seminary was made under questionable circumstances. First of all, there was a leadership vacuum. The prior Seminary rector departed but the new and capable Father Bernard Witek was not appointed yet. He has a viable seminary funding plan and several seminarian candidates. This was not taken into account when the closure decision was taken.

Second, a significant number of members of the Board of Regents was absent during the vote to close the seminary. It is not clear whether they knew the actual issues involved and did not participate in any discussions. They voted by proxy.

Third, all absent members voting by proxy were for closure. This is statistically highly unlikely and probably incorrect. There are enough irregularities to question the validity of the vote to close the Seminary.

Therefore, we ask you to exercise your authority to keep the Seminary open, while Father Witek assumes his position as rector and presents his plans. In the future, a new vote must be taken and all members of the Board of Regents must vote in person, according to organization's by-laws.

#### What has happened since the last meeting:

- Zbyszek finished calling all 100 individual people on Gienek/ Andrzej's list. Almost everyone he spoke with committed (26 people) to contact their Representatives. None of those for whom he left messages replied. He asked to call their representatives and ask them to co-sponsor H.R.82 and H.Res. 664.
- Celina: The Katyń Monument Committee met with attorney Robert Margulis. According to him going to court will be a waste of money. He suggested to write a protest letter and organize a demonstration.

#### What we learned at the meeting:

Orchard Lake Schools. Again, we spent a lot of time trying to figure out what and how can be done not to lose this institution founded by Polonia. Zbyszek presented a controversial article found in "Gwiazda Polarna" by Jolanta Hałaczkiewicz. Jurek: there are 3-4 vacancies in the Regents' Council. To be considered a potential candidate, you need a proper biography and a commitment to donate \$5-10 thousand per year. Władek is convinced that an organization such as OLS, registered as a private non-for-profit corporation, it is not subject to public control and thus its founding documents, By-laws and finances may be legally secret. Gienek and Zbyszek had a different opinion. 
- Poland. Krysia came back a few days ago and talked about her trip.
- Katyń Monument. Celina shared with us the history of the monument and the involvement of her family in this project: the Monument was erected in 1984 and originally not in the present location. It cost \$300,000. As a former councilor, she is convinced that the Planning Board decides what needs to be done and the City Board has no choice but to accept it.

#### Proposals what should be done:

- Jurek promised to invite Fr. Witek to our meeting next week (he was waiting 7 months for a working visa in the US).
- It was repeated that we must obtain the By-laws of Orchard Lake Corporation with all amendments. This could help find ways to save Polish library, archives and museum.
- Tomorrow is the last day for legal intervention (45 days from the approval of the plans) to obtain an order to postpone the spatial development of the area around the Monument. According to some, this is only a way to stop the implementation of plans.
- Krysia: we should try to get an inspection and obtain a declaration that the implementation of landscaping plans around the Monument will create a threat.
- Gienek proposed to keep contact with those who answered Zbyszek's calls via emails.

# What has happened since the last meeting:

- Jurek Różalski prepared a letter to the archbishop of Detroit asking him to reopen the Seminary. Polonia should sign it and send it individually by e-mail or by post.
- An article appeared in "Głos" about the last meeting of World leaders in Geneva. The Biden administration tried to force all countries to listen to WHO. Thanks to the protest of African countries represented by Botswana the proposal failed. Official world media forgot to mention it.
- The title of "Invitation to join our weekly meetings" was enriched with a few variations.
- Zbyszek called 41 people from the Gienek's list. 9 people answered his call. The list includes 98 names not 50 as Zbyszek mentioned before.
- Yesterday, Andrzej organized a Zoom meeting of priest Wróbel from KUL and key people involved in saving Orchard Lake.
- Andrzej exchanged emails with Minister Dziedziczak re the Katyn Monument. The minister sent Andrzej to Director Jan Badowski.

### We talked about:

- We spent a lot of time talking about Orchard Lake. There are no young men willing to enter the seminary and no money to run it we wondered why fight for it. Can we offer the Regents a lifebuoy (money and clerics), as Władek suggested, to save the Seminary? The private Middle School brings money but is not Polish. If we lose the Seminary, will Polonia lose any control of Orchard Lake? Who really owns Orchard Lake? Maybe we should only fight for archives, library and museum.
- Władek: it is very hard to change the mind of people who think differently.
- Krzysiek talked interestingly about the history and the fight to save St. Wojciech, as well as about other Polish churches in Chicago
- Zbyszek shared what he learned by talking to people from Gienek's list. Ultimately, to make it easier, we should have groups of ~15 for one liaison.
- Edmund was surprised, that only 53 people joined the EPA-SID meeting on Monday, as more than 2,000 viewers saw his message on Facebook.

# What we decided:

- We must obtain the By-laws of Orchard Lake Corporation with all amendments. This could help find ways to save Polish library, archives and museum.
- Invitations (titles and text) to our weekly meetings will be changed periodically. Gienek suggested to emphasize not only patriotic, but also personal benefits.
- Edmund was the first to offer \$1,000 to cover initial lawyer's 5 k fee for deferring the implementation of landscaping plans around the Katyń Monument.
- Andrzej will meet again with the Monument group and present a tripartite approach: intervention by a lawyer, letter signed by Polonia to the City Board + demonstration.

# What was done (and what NOT, as planned) since the last meeting:

Suozzi and spoke with his Legislative Advisor Tej on H.Res.664, later attended a rally organized on May 18 by California Retired Teachers Association to repeal the WEP. Among ~80 teachers, social workers and firefighters, from all over the country, were also: Elizabeth Baumgartner (PAC-LI) and her husband, Wojtek Jeśman (PASI), Jacek Marczyński (PASI, CPA, PAC), Gene Sokołowski (PASI-EDU, one of the speakers). Three congressmen (Larson was first) and one senator were speaking. Andrzej and Wojtek filmed the event. Pictures are attached under this report;
- Andrzej and PASI leadership were successful in bringing reps of two main organizations that take care of Katyń Monument and other individuals excluding only Ms. Piórkowska to Zoom meeting. Sławek Platta, who helped for gratis (Polonia did not have to pay \$35k) when there was the attempt to move the Monument, estimated the legal cost now on 10-60 k dollars.
- Halina: the money would not be a problem if we had a Foundation and this shows how important it is to start working on this idea;
- Tomek has NOT received an answer from President of Ukrainian organization to become co-signatory of the letter to congressmen re H.Res.664.

#### What we talked about:

The reason: the amount of mail received each day is overwhelming and staffers do not have time to respond all senders and satisfy their requests;

- Krzysiek showed us a picture of the sticker: concentration camps were not Polish.

- All interested will work on improving the draft Zbyszek prepared to attract more people to our meetings;

# What was done (and what NOT, as planned) since the last meeting:

- Zbyszek registered for a rally organized to repeal the WEP which will be held at the Capitol in DC, on May 18;
- Andrzej, Halina, Zbyszek and many other reps of Polonia participated at the Zoom Jersey City Board Planning meeting, on Tuesday May 10. Unfortunately, the public was not invited to comment and the Master Plan was approved giving the developer a free hand to implement his land use plans around the Katyń Monument;

- Zagłada (Holocaust), a play in Kosciuszko Foundation (KF). Zbyszek found out that Dr. Fogelman is a longtime friend of KF's President and that it could be a factor in allowing the play to be performed in KF. He also prepared the response which with improvements of Halina, Andrzej and Krzysiek were emailed to presidents of PAC divisions and other organizations with the request to support it (is attached below this report).
- 2) Letter to Vice Minister Anna Schmidt. Leszek Pawlik, President of Coalition of Polish Americans after several requests by Andrzej, and in the end by Halina, finally signed the letter last Monday. However, he changed the word "błędna" to "niekorzystna" which makes the letter according to Gienek pointless. Leszek sent an enigmatic email that he does not have time to deal with this issue anymore. Lack of will by Leszek to cooperate with us is nerve-wracking. In the response to Ms. Schmidt, we should explain why we reply with the delay and only Staszek should signed it as the "case handler" (assuming that Leszek has not sent the letter).
- 3) The Comic "Maus". All agreed that portraying Poles as pigs and those who cooperated with "cats" (Germans) is particularly perfidious. Recommending this book to be a part of curriculum on Holocaust in schools should be forbidden. Andrzej read to us the draft of letter to the House Committee on Education and Labor prepared by PASI (Wojtek Jeśman and Gene Sokolowski). The letter made a very positive impression on participants. Following suggestions were made:
  - a) In the "Second" argument, mentioning that "only in Poland those who helped Jews, in some way, were murdered by Germans."
  - b) In the "Fifth" argument, the sentence should be rephrased "The following nations suffered the most; ". Without "and many others". As there were NOT many others.
  - c) In the last paragraph: instead of "directors of public instruction" for us sounds better "directors of public education".
- 4) The Piorun (meaning "thunderbolt") is a <u>man-portable air-defense system</u> of Polish production, designed to destroying low-flying aircraft, airplanes, helicopters and unmanned aerial vehicles. Władek told us about this unique Polish invention that even Americans are buying and which recently were also sent to Ukraine.
- 5) **Thank you letters to supporters of H.R. 82.** Jacek sent the list of supporters to Andrzej and he is going to distribute the letter to them.
- 6) **Katyn Lesson** Andrzej, Krzysiek and Zbyszek will meet with Anna Tracz and Jan Kozioł via Skype this Monday at 7 PM to find the best way to distribute the lesson.
- 7) **Recruiting people to work in the Polish organizations**. Władek has an idea and he will prepare a draft of arguments why it is important to be active and get involved.
- 8) **Rep. John Larson's proposal H.R. 5723** was summarized by Gienek. It is obvious that Larson is trying to derail H.R. 82. Gienek will prepare a reply to be used for Krysia.
- 9) **H.R.3485** Global Respect Act was mentioned by Andrzej and he showed us via GovTrack.us which Reps supported this shameful legislation.

Kościuszko Foundation znamy jako organizację, która nie jest obojętna na fałszowanie historii.

KF dała tego dowód choćby w ubiegłym roku przez szybką reakcję na wypowiedź kongresmana Steve'a Cohena oraz poparcie rezolucji H.Res. 664 dotyczącej II wojny światowej.

Z tym większym zaskoczeniem, a nawet szokiem spotkało się ogłoszenie KF o prezentacji (10 lutego br.) scenariusza sztuki "Zagłada" o polskim kapo, który został ujawniony przez "African-American journalist". Bez podania głębszego kontekstu, taki przekaz został odczytany jako popieranie przez KF wrogich Polsce i prawdzie historycznej kręgów, których celem od lat jest pomniejszanie odpowiedzialności Niemców za zagładę Żydów i obarczenie nią Polaków.

Takie prowokujące ogłoszenie okazało się skuteczne i przyciągnęło szukającą sensacji publiczność. To jednak niestety zaszkodziło reputacji KF jako instytucji w tym przypadku biorącej udział w działaniu odebranym jako antypolskie.

Zależy nam na tym, aby tak zasłużona instytucja jak KF nie była postrzegana negatywnie przez Polonię. Naszym zdaniem KF powinna zdecydowanie odciąć się od działań, które mogą być odbierane jako antypolskie. W kulturze amerykańskiej takich działań jest wiele.

Sorry, for being late. I joined a few minutes before 4 PM. I am glad that all interested in these meetings managed to join on time and began the meeting without waiting for me.

1) Zagłada (Holocaust), a play in Kosciuszko Foundation (KF). The play was advertised in a following way: Zagłada is about a 90-year-old Polish man living in Maspeth, Queens, who is exposed by an African-American journalist as having been a Kapo in Buchenwald. The man shoots at the journalist, is arrested for firing an illegal firearm, and is held at the 112th Precinct by an NYPD Intelligence Bureau Officer. There he is forced to confront his past by a Federal Prosecutor who is driven by a personal vendetta.

This issue was discussed for an hour. What by showing this play KF wanted to achieve Zbyszek will investigate, also why this play was accepted for presentation and he will propose our reaction.

- 2) The fight with the WEP. Leszek Pawlik refused to sign the letter prepared by Teofil, our lawyer. He would like to change some wordings; his suggestions were discussed. Leszek's last statement in his email suggests that he does not wish to continue the exchange with Vice Minister Anna Schmidt (a year of our efforts would be waisted). The letter was already signed by Dr. Śliwowski and we may send it only with his signature, as a "case handler" and former President of Coalition of Polish Americans.
- 3) Katyn Lesson. Zbyszek received response from President of Polish Saturday Schools, Dr. Dorota Andraka; she apologized for making us wait for her reply and named two persons Anna Tracz I Jan Kozak who will work with us to make the lesson available for teachers worldwide. Zbyszek showed also the site "History in pictures" (Historia w obrazkach) as example of clarity in presentation that we could follow for the Katyn Lesson and other ones which hopefully we will prepare. This site was compared with the lesson on the CPA site.
- 4) PAC Missouri Division website. Gienek spoke about what could be behind the success of his division's website. The 4-person team decides what will be placed on their site. They look for issues that in their opinion are interesting. Simplicity could be another factor that visitors like. From 2016 (the inception), their site was visited by 102 thousand people.
- **5)** Meeting of the PAC National Executive Council (Wednesday, Feb. 2). Andrzej and Richard participated in that meeting and shared what the learned that Tom Kolodziej and Bozena Kaminska, VPs for American and Polish Affairs will conduct monthly meetings with divisional VPs.

- 1) 82<sup>th</sup> Anniversary of the first transportations to Auschwitz. Krystyna wants us to remind Americans about the first transport of 728 Polish political prisoners on June 14, 1940, who were transported to Auschwitz from a prison in Tarnow, south Poland. In the group were Polish soldiers caught while attempting to flee to Hungary, members of the resistance, students, school youth and several Polish Jews. The lengthy discussion followed (over an hour) about using the travel Auschwitz exhibit which Zbyszek, after a donation made by PAC-LI, received from Andrzej Prończuk, PhD President of Polish American Cultural Foundation in Boston. It was agreed that the exhibit should be showed on the Capitol or in the Holocaust Museum in DC. Possibility of using a projector and a wall was considered. Gienek suggested to use our websites to inform about the exhibit. Andrzej proposed to organize a team that would be responsible for implementing Krysia's idea. Krzysiek: the best way, to reach the widest audience, would be to make Catholic schools interested in this matter. Possibility of virtual tour was presented by Andrzej. We must prepare an introduction to the exhibit, emphasizing that Poles also were victims, Krzysiek reminded.
- 2) The fight with the WEP. A letter to minister Anna Schmidt was prepared by Teofil and discussed by the group responsible for this project last Thursday at 8 PM. It waits to be signed by Dr. Stanisław Śliwowski former and Leszek Pawlik present President of Coalition of Polish Americans. Copies of the letter will be sent to minister Dziedziczak, Frank Spula, President of PAC and Jerzy Kwaśniewski, President of Ordo Iuris. Edmund reminded that the letter must be sent via FedEx. Thank you notes has not been sent yet to those who signed the letter to congressmen supporting H.R.82. Jacek will be able to do that after he comes back from Toronto in two weeks. Krysia called the office of her Rep. John Larson and asked why he has not yet sponsored H.R.82. She waits for a response. Gienek was wondering if 98 congressmen whose faxes did not work were informed by Jacek.
- 3) Books about atrocities against Poles in libraries versus present priorities. Krysia's idea, to request our local libraries to order 3 books, has not been executed by anybody in our group. Most of us are busy implementing other projects. Zbyszek mentioned that he has a list of 40 proposals sent by a dozen of PAC members, as the response to his questions sent to ND\_Forum in the Fall of 2017. Krzysiek: there is only a handful of us working on a few projects, thus we must prioritize our efforts otherwise we will not be effective.
- 4) Plans to meet w/ Ambassador Magierowski. Zbyszek's proposal to send a request for a meeting with the ambassador presented to Frank Spula, President of PAC and a couple days later also to Leszek Pawlik, President of Coalition of Polish Americans were rejected by both gentlemen. Presidents of other organizations will be approached. Andrzej already has a question for the ambassador: what are the Polish government's plans are to ameliorate the image of Poland and how we could help. Władek would like the consulates to improve their service.

Tomek's mom passed away at age 71 after 3 years of fight with the colon cancer. All joined in expressing sincere condolences.

- 1) Echoes from the meeting w/ Ambassador Brzezinski. Edmund and Tomek were briefed about some details of this event. The list of participants is under this report
- 2) Meeting w/ Senator Rob Portman. Tomek told us about today's morning meeting over the phone with his Ohio Senator. There were 15 participants, including Consuls of Estonia, Lithuania, Macedonia and Ukraine. Mr. Portman came back from Ukraine and he shared his views. He spoke very positively about Poland, praising her decisions, most likely because of purchasing Abrams tanks produced in Ohio. Tomek asked him if the gas pipe II will be used as a bargain in present negotiations with Russia and about missiles with nuclear heads in Kaliningrad. Answers were diplomatic and fuzzy.
- **3)** Actions concerning the WEP. Letter to minister Anna Schmidt was prepared by Teofil and will be discussed by the group responsible for this project tonight at 8 PM. Thank you notes has not been sent yet. Jacek was too busy.
- 4) Plans to meet w/ Ambassador Magierowski. An email to the Ambassy w/ a request for a meeting was presented and discussed. It was suggested to contact Leszek Pawlik and ask him if he wants to be signed besides Richard Brzozowski representing Polish American Congress Long Island Division and Jacek Marczyński representing PASI.
- 5) Covid vaccines. Tomek told us how Dr. Ugur Sahin and Dr. Özlem Türeci, Turkish co-founders of BioNTech SE based in Mainz Germany designed the vaccine (I found that they did it just in a few hours over a single day in the summer of 2020). Pfizer got the vaccine from them and others followed their concept; messenger RNA (mRNA) vaccines teach our cells how to make a protein that will trigger an immune response inside our bodies. The J&J/Janssen vaccine is different; it contains a piece of a modified virus that is not the virus that causes COVID-19. This modified virus is called the vector virus. The vector virus cannot reproduce itself. This vector virus gives instructions to cells in the body to create an immune response. This response helps protect us from getting sick with COVID-19. This short explanation how two different types of vaccines work, I added to this report.
- 6) Publishing Katyn Lesson in Assistant. Andrzej wrote to Ms. Jujka about this intend the last September. Zbyszek volunteered to push this issue forward.
- 7) Movie about priest Stefan Wyszyński. The period of his life during the Warsaw uprising. Halina and I saw it in a Parish Hall and strongly recommend it. It has English subtitles.
- 8) Agenda for Polonia. Władek suggested to find a goal that could unite Polish American organizations for example: preventing the assimilation of the Polish diaspora.

- Summary of the meeting w/ Ambassador Brzezinski. A press release was prepared and sent to PAP (Andrzeja Dobrowolskiego). It was emphasized that: we are happy the meeting took place at all, so many organizations which normally do not cooperate participated, issues important to Polonia were presented to Ambassador and a communication channel opened. More info is attached below this report.
- 2) Meeting w/ Ambassador Marek Magierowski. Władek proposed to organize a meeting with the new Polish Ambassador in Washington. We may raise the issue of the method used to calculate retirement benefits in Poland that causes the WEP to apply to Polish immigrants. Gienek approached the previous ambassador, Prof. Wilczek without a success, as he directed Gienek to the Social and Family Department.
- 3) Actions concerning the WEP. Edmund: we should continue what we started w/ minister Anna Schmidt and we should press for H.R, 82 to be put for voting by the Social Security Subcommittee. Teofil has still not prepared a letter which supposed to be a reply for the letter we received back in September. Andrzej will try again to contact him. Jacek will work with Andrzej to send thank you letters to those who supported the H.R.82 bill. Andrzej had high fever and Jacek had covid, both were not able work on this project. Andrzej found that chair of subcommittee is John Larson the Rep. of Krysia and she is willing to approach him. She will need a text she can use to convince her Rep. to submit H.R. 82 for voting.
- 4) Project concerning suffering of Poles. Krysia: her propose to organize a lecture on Polish victims was accepted by her library. She is expecting other members of our group will follow her example she is ready to help. Krysia also mentioned about the movie "Little Poland" in India that will be presented. Spotkanie przedstawicieli organizacji polonijnych z Markiem Brzezińskim, nowo zatwierdzonym Ambasadorem USA w Polsce. (przykład działania PACT-u)

Kandydatura Marka Brzezińskiego na ambasadora Stanów Zjednoczonych w Polsce ogłoszono 4 sierpnia 2021. Polonia przyjęła to z dużym zadowoleniem. Wkrótce po tej wiadomości, na jednym z cotygodniowych zebrań PACT-u (porozumienia między grupą działaczy, którego celem jest wymiana informacji i praca nad realizacją projektów) Wiesław Gołębiewski, Prezes Światowej Rady Badań nad Polonią zaproponował, żeby przedstawiciele Polonii spotkali się z Markiem Brzezińskim. Półtora miesiąca później w październiku miały swoje coroczne osobne zjazdy: Koalicja Amerykanów Polskiego Pochodzenia oraz Kongres Polonii Amerykańskiej. Propozycja spotkania z ambasadorem na tych zjazdach jak również na innych odbywających się wcześniej konferencjach nie była dyskutowana.

O pomyśle zorganizowania spotkania nie zapomniał Zbigniew Koralewski, Wice Prezes ds. Amerykańskich w Wydziale Long Island Kongresu Polonii Amerykańskiej oraz założyciel i prowadzący PACT. Czas mijał i nikt nie podejmował starań w tym kierunku. Wobec tego, na zebraniu PACT-u 1 grudnia 2021 roku, otwartego jak zwykle dla wszystkich zainteresowanych działaniem dla dobra Polonii, przedstawiono plan realizacji tego pomysłu.

Pierwszy etap polegał na nawiązaniu kontaktu z Ambasadorem co wymagało dotarcia do odpowiedniej osoby. W sobotę, 18 grudnia 2021 senatorowie jednogłośnie podjęli decyzję i Mark Brzeziński został zatwierdzony na ambasadora USA w Polsce. Dopiero wówczas rozpoczęła się wymiana emalii z asystentem ambasadora, przerwana długimi wakacjami świątecznymi oraz nowym rokiem. Były poważne obawy czy spotkanie dojdzie do skutku. Mimo tych wątpliwości Zbyszek Koralewski kontynuował codzienne spotkania przez Skype z kilkoma zaangażowanymi osobami nad przygotowaniem pytań do ambasadora.

W środę 5 stycznia, dostaliśmy krótki email o 5:12 PM, a następnie w czwartek 6 stycznia z biura Ambasadora ze szczegółowymi informacjami dot. spotkania i zaskakującą datą wyznaczoną na następny dzień, czyli piątek, 7 stycznia 2021 na godzinę 12:30. Jak wspomniałam wcześniej, nie wiedząc czy spotkanie dojdzie do skutku, czekaliśmy z oficjalnym powiadomieniem przedstawicieli organizacji polonijnych. Po otrzymaniu zielonego światła, okazało się, że mamy dosłownie jeden dzień, aby zebrać szeroką reprezentację organizacji, które zwykle ze sobą nie współpracują i przygotować się wspólnie, do tego ważnego wydarzenia. Ustaliliśmy, że spotkanie będzie prowadził Ryszard Brzozowski, prezes Wydziału KPA Long Island, weteran Armii Amerykańskiej.

Czasem zdarza się, że plany nie zawsze udaje się zrealizować. I tak było tym razem. W piątek przed południem Ryszard musiał odwieźć swego przyjaciela do szpitala i nie mógł uczestniczyć w spotkaniu. Plan B, tzn. osoba mająca zastąpić Ryszarda, również nie doszedł do skutku. Wobec powyższego rolę prowadzącego spotkanie w ostatniej chwili objął Zbyszek Koralewski. Na początku spotkania pogratulował ambasadorowi zatwierdzenia go na to reprezentacyjne stanowisko. Następnie podziękował za przyjęcie zaproszenia i za gotowość zapoznania się ze sprawami ważnymi dla Polonii. Zbyszek kontynuował: "mamy duże oczekiwania, ponieważ pan jest synem Zbigniewa bardzo szanowanym przez Polaków na całym świecie". Przypomniał też, że jest on drugim ambasadorem amerykańskim, który ma polskie pochodzenie, w ciągu ostatnich 100 lat, tzn. od odzyskania niepodległości. Zbyszek wskazał na sprawy szczególnie istotne dla Polonii: nawiązanie dwustronnej komunikacji z Ambasadą Stanów Zjednoczonych w Warszawie oraz bezpieczeństwo Polski. Po krótkim wystąpieniu ambasadora rozpoczęła się sesja pytań i odpowiedzi.

Spotkanie, które trwało ponad godzinę, przebiegło w przyjaznej i serdecznej atmosferze. Uczestnicy przedstawili 10 spraw ważnych dla Polonii, dotyczących relacji polskoamerykańskich i wskazali na kwestie, które wpływają na poważne osłabienie nastrojów proamerykańskich w Polsce. Prezes KPA Frank Spula, zakończył spotkanie i wyraził nadzieję, że obecny Prezydent USA będzie dotrzymywał obietnic w stosunku do Polski, tak jak to robił jego poprzednik. Dołączył się też do pozostałych osób zabierających głos, życząc ambasadorowi sukcesów na placówce dyplomatycznej w Warszawie.

Należy podkreślić, że do sukcesu spotkania przyczyniło się pełne poświecenia zaangażowanie w pracę nad tym projektem Andrzeja Burghardta i Krzysztofa Węża, należących do grupy PACT, którzy ściśle współpracowali ze Zbyszkiem.
